EVERY CREATURE COUNTS - FERAL CAT SERVICES

Every Creature Counts offers a service to the community to decrease the feral cat population and help people involved with TNR (trap-neuter-return), by offering spay/neuter and vaccination services.

FERAL CAT PACKAGE - \$15

Spay or neuter, 4-in-1 combination vaccine (Feline panleukopenia/ rhinotracheitis/calicivirus/chlamydia), Rabies vaccine, & Penicillin injection.

Appointments are not necessary for feral cats, however, cats need to be dropped off and picked up during the designated times. Please call ahead to confirm any closure dates.

Patient Drop-off 7:00 am - 7:30 am Patient Pick-up 3:00 pm - 4:30 pm

Cats must arrive in separate traps. Individual carriers, with clean bedding, must be provided for cats to recuperate in following surgery. It is recommended that cats are kept in a protected area following surgery, to allow for post-surgical monitoring. The area should be clean, warm, and dry, and isolated from other animals. Check on the cat periodically to ensure that recovery is progressing. If you see any signs of bleeding, difficulty breathing, or excessive vomiting, please contact Every Creature Counts immediately. It is recommended that males be monitored for 24 hours following surgery and females be monitored for 36 to 48 hours following surgery. All services are cash only and payment is due at time of service.

DOGS AND CATS

Please be a responsible pet owner and have your dogs and cats spayed or neutered. Many millions of animals are destroyed every year because there are too many and not enough homes. Remember, the City requires all dogs and cats to have current rabies shots and to be licensed by the City. It is important to have your dogs and cats immunized so they don't spread diseases, and for your animals' general health. The animal license requires proof rabies shots are current, and the fee is \$10; with proof of spay or neuter, the charge is reduced to \$2. Licenses are valid for one year. Dogs at large will be impounded and you will be charged a \$20 impound fee and \$15 dollars per day or partial day for boarding, plus any charges for rabies shots and/or licensing.

SNOW REMOVAL

City Ordinance, Sec. 11-1 Removal of Snow:

"It shall be unlawful for any owner, or the agent or the tenant of such owner, of any lot, block or parcel of land within the City to allow any snow, sleet, ice, dirt, debris or any other obstruction to accumulate or to remain upon any sidewalk adjoining such lot, block or parcel of land within the City, longer than twenty-four (24) hours from the time of the last accretion of such snow, sleet, ice, dirt, debris or other obstruction."

Street Plowing Guidelines: Colorado Department of Transportation (CDOT) is responsible for sanding and snow plowing Hwy 85, Hwy 52 and Business Hwy (Denver Avenue North). On Business Hwy 85 from Hwy 52 to 5th Street, snow will be plowed to the center of the street by CDOT & will be removed by Public Works. Contact CDOT for questions at 970-962-4025.

First priority for sanding & snow plowing are streets adjacent to public facilities such as the Police Dept, Fire Dept, schools, and City Hall. Routes may be sanded/ plowed at the request of emergency personnel due to life threatening emergencies.
